Call to Order

Vice President Fine called the regular meeting to order at 5:02 p.m.

Roll Call

The following Board members were present: Vice President Fine, Rarick, and Watkins. President Turner and board member Sunderman were absent.

Approval of Agenda

A motion was made by Watkins, seconded by Rarick, to approve the agenda. Motion carried 3-0.

Audience to Visitors

Vice President Fine welcomed all visitors to the meeting. No visitors chose to address the board at this time.

Administrative Reports

Mr. McNeal, Middle School Principal, reported:

- 1. Seventh and eighth grade band members traveled to Platte City, Missouri and World of Fun in Kansas City on Saturday to perform and then enjoy a day of fun.
- 2. The 6th-7th-8th grade band will participate in the Red Oak Band Festival on Saturday, April 28th.
- 3. We will host a 7th/8th boys' track meet this Tuesday and then the boys will be in Red Oak on Thursday. The girls will compete at Shenandoah on Tuesday and Glenwood on Thursday.
- 4. Spring concerts for vocal and band are next week; 7th/8th on Monday, 5th/6th on Tuesday.

- 1. We will host the last of this season's five track meets tomorrow. We couldn't have done it without a great group of community and staff volunteers.

Mrs. Whitham, Elementary Principal, reported:

Craig Hill, Maintenance Supervisor, reported:

1. We've had three contractors assess the problem with the middle school boiler and all agree it would be in our best interest to replacement the boiler at this time rather than attempt to repair it. We'll be receiving competitive quotes for two Aerco boilers prior to the May 14th board meeting. The work can be done this summer and it appears we won't need excessive plumbing changes. We currently have Aerco boilers in the high school and the McKinley buildings.

New Business

Report on DeCat Funded Student Assistance

Cindy Aldrich, After-School Program Coordinator, and Mr. McNeal, Middle School Principal, were on hand to share information about the After-School Tutoring Program and the new summer program to be launched in June. For over ten years the District has been fortunate enough to receive funding from the Fremont, Page, and Taylor DeCategorization Board. Decategorization is designed to redirect child welfare and juvenile justice funding to services which are more preventive, family-centered, and community-based in order to reduce use of restrictive approaches that rely on institutional, out-of-home, and out-of-community care. The After-School Tutoring Program started the year with 23 high school tutors working with over 40 students from grades 4-8 in the areas of homework completion, reading skills, math skills, and study skills. They meet Tuesday and Thursday for an hour each afternoon. Additional funding is now providing an In-School Program with three high school students transported to the K-8 building during the school day. They are currently working with six students in reading and math. The new summer school program will be held in June. Plans are to include 15 students per grade level, 3rd-6th, three hours a day for two days each week. Three one-hour periods will be utilized: reading, math, and fitness. Instruction will center on basic skills and fundamentals in math, reading skills and comprehension, various physical activities and promotion of a healthy lifestyle and wellness.

Approve Gym Renovation Bids

A motion was made by Watkins, seconded by Rarick, to approve the base bid of \$130,614 from Rife Construction of Omaha to complete the general contractor portion of the high school gym project. Motion carried 3-0.

A motion was made by Watkins, seconded by Rarick, to approve the resignation from Maria Jacobus as middle school teacher, girls' golf, and high school yearbook sponsor effective the end of the current school year. Motion carried 3-0.

A motion was made by Rarick, seconded by Watkins, to approve the resignation from Crystal Wittmer as high school art teacher and junior class sponsor effective the end of the current school year. Motion carried 3-0.

A motion was made by Watkins, seconded by Rarick, to approve the resignation from Julie Maurer as elementary teacher effective the end of the current school year. Motion carried 3-0.

A motion was made by Rarick, seconded by Watkins, to approve the resignation from Kristine Wilson as high school English and assistant volleyball coach effective the end of the current school year. Motion carried 3-0.

A motion was made by Watkins, seconded by Rarick, to approve the resignation from Linda Poore as elementary teacher effective the end of the current school year. Motion carried 3-0.

Approve 28E Athletic Sharing Agreement

A motion was made by Rarick, seconded by Watkins, to approve the 28E Athletic Sharing Agreement with South Page Community School District to participate in the Clarinda wrestling program for the 2012-2013 school year. Motion carried 3-0.
