# **Administrative Reports**

Miss Nook, High School Principal, reported:

- 1. We are concluding Iowa Assessments for students who were absent during testing and will be remitting them for scoring soon.
- 2. The second trimester will end on February 22<sup>nd</sup>.
- 3. The Iowa Supreme Court has asked if Clarinda High School could host the Court as it presents oral arguments on Tuesday, March 11<sup>th</sup>.

#### Mr. Irvin, Activities Director, reported:
