This week, I would like to share a few items regarding the Clarinda Community School District calendar. At our next board meeting, Wednesday, February 23, 2022, the board will take action to approve or deny the proposed calendar for the 2022-2023 school year.

A team consisting of teachers and administrators created the draft calendar using professional learning for teachers as a main driver for decision-making. The calendar was sent to all staff, a public hearing date was set on January 26<sup>th</sup>, and a public hearing will take place at this week's school board meeting on February 23<sup>rd</sup>. If approved, families and staff will be able to begin any necessary planning.

Q: If my student is currently open enrolled, do I need to "re-apply?"

A: Once a student is approved for open enrollment into a district, the student is a member of that district. The only exception would be if the open enrollment agreement was "broken" by a parent/guardian deciding to homeschool or choose another option. At that point, the process starts over.
